Opening date and time of financial bid shall be communicated subsequently after assessing the suitability and eligibility of the bidders.

1. Scope of Work:-

- 1.1 Supply of Rack SERVER and Rack at Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore-641043, Tamil Nadu
- 1.2 The specifications of Supply of Rack SERVER and Rack should be as per Annexure A(ia) and A(ib)
- 1.3 Successful bidder shall be required to supply and install the ordered items within 30 (Thirty) days from the date of work order.

2 Eligibility Criteria for Bidder:

The bidding concern must fulfill all the following criteria for techno-commercial qualification of the tender.

- 2.1 The bidder should be registered under Indian law as a business entity (attach document)
- 2.2 The bidder must have valid PAN, GST (attach document)
- 2.3 The firm must not have been debarred/blacklisted by any Govt. Dept., agency, PSUs /

Institution / agencies / autonomous organizations. The bidder shall submit a self-certification by an authorized person duly notarized to this effect in the prescribed format attached as Annexure A (iv)

- 2.4 Only manufacturer(s) or their authorized distributor / agent are eligible to bid. authorization letter in

the prescribed format (Annexure – A (iii)) from Original Equipment Manufacturer (OEM) in favour of authorized Agent to bid / negotiate / conclude the order against this tender, must be enclosed with technical bid for all types of proposed items.

2.5 Bidder is also required to submit certificate from OEM for item mentioned in Annexure A(ia) in prescribed format annexed at Annexure A (v).

3 INSTRUCTIONS TO BIDDERS

- 3.1 A bidder can submit a single bid only.
- 3.2 Incomplete, telegraphic or conditional bids shall not be accepted.
- 3.2.1 The contractor /firm shall not be allowed to transfer, assign, and pledge or sub- contract work order/supply order under this contract to any other agency.
- 3.3 Prices quoted must be firm and fixed. No price variation / escalation shall be allowed during process of completion of the project.
- 3.4 The bidders must sign at the bottom of each page of the bid documents at the time of submission in token of unconditional acceptance of the terms and conditions, technical specifications etc.
- 3.5 Valid GSTIN certificate / e-submission document duly self-attested must be submitted along with the bid.
- 3.6 Deviations in terms and conditions, Specification of material, Inspection clause etc. will not be accepted under any condition
- 3.7 Bids received late due to postal delay or otherwise will not be considered.
- 3.10. The bidders are required to furnish their offers in the price bid both in words & figures. In case of corrections if any, the original text/numerical must be clearly crossed out and re-written legibly above, below or on the side of the crossed out characters as per availability of space and the authorized person must put his dated initial under such corrections. In case of any conflict between figures and words, the latter shall prevail.
- 3.8 Since timely execution of works is of paramount importance, requests for extension of time shall not be entertained.
- 3.9 Canvassing in any manner shall not be entertained and will be viewed seriously leading to rejection of the bid.
- 3.10 Institute reserves its right to modify the bid document/details by way of amendment.
- 3.11** Bids will be accepted & will be opened as per information mentioned in the notice-inviting tender. No receipt against submission of bid shall be issued by Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore-641043. Tamil Nadu, India

- 3.12 The last date of receipt of the bid is **16.03.2020 upto 2.00 pm.** sealed tenders may only be dropped in the specified tender box kept in the Office of The Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore, during office hours on working days. Bids received after due date & time will not be considered. If due to any reason the due date is declared as a holiday the bid will be opened on next working day at the same time.
- 3.13 Signed & stamped compliance sheet of the technical specification of the goods with technical printed literature along with Bill of Material (BoM) mentioning all the terms & conditions clearly, must be enclosed with the technical bid.
- 3.14 The technical bid shall be opened on **16.03.2020 at 3.00 pm.**in The office of Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore in presence of such bidders or their authorized representatives, who are present at the time of opening. (The bid document should be submitted in two parts as detailed below:
- 3.14.1 Bids should be submitted in two separate sealed envelopes as mentioned below & addressed to the Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore, inside a sealed envelope superscribed "**Bid for Supply of Rack SERVER and Rack**". First sealed envelope should contain Technical bid as per Annexure–A(ia) and A(ib) prescribed Firm Registration certificate, Technical Specification, GST Registration Commercial terms & conditions, Compliance Sheet, other bid documents duly signed & sealed.
- 3.14.2 It should be superscribed with "**Part-1 Technical Bid**". All the papers of bid documents except the price bid duly signed should be submitted in the first envelope..
- 3.14.3 Second sealed envelope should contain Price bid as per Annexure – B in a separate sealed envelope. It should be superscribed with "**PART II Financial Bid**". Any condition in regard to financial aspects, payments, terms of rebate etc. beyond the prescribed financial terms of Avinashilingam Institute for Home Science and Higher Education for Women Coimbatore, will make the bid invalid. Therefore it is in the interest of the bidders not to write anything extra in the Price Bid in Annexure-B except price.
- 3.15** The procedure of opening of the bid shall be asunder:
- 3.15.1 First envelope "PART-1 Technical Bid" shall be opened at the time & date mentioned in the bid notice by Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore representative in the presence of bidders, who choose to be present.
- 3.15.2 Second envelope containing Price bid shall be opened after evaluation of technical-commercial suitability of the offer by assessing responsiveness in line with the requirements mentioned in the bid document. The time for opening of second envelope (Price bid) shall be informed separately after assessing and evaluation of technical bid.

Second envelope of price bid be only those bidders shall be opened who qualify in the technical bid. If necessary, the firms may be called for Technical Presentation of their product as per the time intimated by Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore.

Successful bidder shall be calculated on the basis of total cost of all items as mentioned in technical bid.

3.15.3 In case of supply of any defective material or substandard material, the materials will be rejected & it will be the responsibility of the supplier for taking back & replacing the rejected materials at their own cost. In case of non-lifting of such rejected materials within a reasonable time offered by the office it will have the right to suitably dispose off the same and forfeit the amount.

3.15.4 The supplied materials should strictly comply with the specifications as mentioned in the bid, otherwise the material would be liable for rejection.

3.15.5 Any clarification on the technical specification and commercial terms and conditions may be clarified in writing from Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore through email and reply shall be sent by email only.

- Deviation of any commercial terms and condition and technical specification shall not be entertained under no circumstances.
- Bidders may in their own interest visit the sites and undertake site visit before submitting bids. Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore will not be responsible for any incidental or consequential losses of the firms while execution and till expiry of the period of maintenance.
- The contractor shall abide by all laws, rules and regulations framed there under or any other statutory obligations which are in force from time to time. The contractor/firm shall indemnify the Institute from any claims in this regard.

3.17 Any losses sustained by the Institute due to negligence of contractor's service in the form of loss/damage of property, will be recoverable from the contractor, as the money value shall be estimated by the Institute. The decision of the Institute in this regard will be final and binding on the contractor/firm.

The Contractor/firm will adopt all safety measures /precautions while executing the work/supply. In case of any accident /causality of any personnel, involved in work/supply the complete responsibility will be borne by the contractor/firm himself and Institute will not be held responsible for any claim/compensation.

The tenderer shall submit the copy of the tender document and addenda thereto, if any, with each page should be signed and stamped to confirm the acceptance of the entire term & conditions of the tender.

4 OEM's PRE-QUALIFICATION CRITERIA

The bidder shall be required to obtain certificate from OEM for following

S.No	Specific Requirements
1.	OEMs of major items should not be blacklisted by any Ministry under Government of India or by Government of any State in India or any of the Government PSUs as on tender floating date.
2.	The proposed items OEM should have direct presence in India for more than 5 years as on bid submission date (not as joint venture, partnership firms or through any other associated)
3.	The proposed items OEM should have own RMA set up in India for last 3 years from the date of submission of bid (not as joint venture, partnership firms or through any other associated)
4.	OEM of proposed items must be ISO certified
5.	The proposed items should be from the same OEM to ensure seamless integration and single point of contact and ownership from the Audio Visual Aids OEM.
6.	The proposed items OEM should have its toll free number in India for any technical support query from the SI or end customer.

The certification should be in prescribed format at Annexure A (v) on letterhead of OEM.

5 ACCEPTANCE/ REJECTION OF THE BID DOCUMENTS:

The Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore reserves the right to reject or accept any bid or annul the bidding process at any time prior to award of contract, without having prejudice of incurring any liability to the affected bidders or any obligation to inform the bidders.

6 COMMERCIAL TERMS & CONDITIONS:

6.1 Rate :

The offer should indicate the complete cost of the work including design, manufacturing and Installation & Commissioning charges, taxes & duties. The unit cost must be inclusive of packing, forwarding, loading & unloading charges, cost of insurance and transportation FOR destination where the system will be installed as per the work order.

6.2 Taxes: All Taxes as applicable should be mentioned clearly in price bid.

6.3 Warranty: Warranty for proposed items should be mentioned clearly in the bid.

6.4 Installation: Installation charges if any should be mentioned clearly in the bid.

6.5 Make and Model: Make and Model of the proposed item should be mentioned clearly in the bid. The item should not be an assembled item.

6.6 Training: Successful bidder should provide the training for the proposed items at free of cost.

6.7 SECURITY DEPOSIT:

- The successful bidder must deposit the Security amount @ 5% of the ordered value with The Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore within the time frame provided in letter for depositing of security in shape of DEMAND DRAFT OR irrevocable Bank Guarantees of equivalent amount for a period of one year.
- The security deposit would be forfeited, if the firm/contractor denies to execute the work or supply the ordered items as the case maybe.
- The security deposit would be forfeited, if the supplies are not made or work not done as per the Terms & Conditions of the purchase order/bid document.
- The security deposit amount will be refunded after the period of Six Months without any interest.

6.8 Payment:

Payment will be made after satisfactorily completion of work as per specifications after submitting of bill by firm.

In case supply /work are not found as per specifications of the Institute, whole supply/work shall be rejected and there shall not be any liability towards University for any reason.

6.9 Liquidated Damage Clause:

If the supplier fails to deliver the equipment / materials within the time specified in the contract or any extension thereof, the purchaser shall recover from the supplier as liquidated damages, a sum of half percent (0.5%) of the contract price of the undelivered equipments / materials for each completed week of delay. The total liquidated damages shall not exceed ten percent (10%) of the total contract price. Only the date of actual receipt of materials at stores will be reckoned as date of delivery for this purpose.

Equipment will be deemed to have been delivered only when all its component parts are also delivered. If certain components are not delivered in time the equipment will be considered as delayed unless the missing parts are delivered. Liquidated damages will also be levied for the quantity not supplied as is done for the delayed supplies. If supplies are effected in part which could not be beneficially used by the Institute (due to such incomplete supply), liquidated damage will be worked out on the basis of entire contract price only and not on the value of delayed portion.

If supplies to be rendered are made by the supplier beyond the period of delivery and they are accepted by the Institute, such acceptance is without prejudice to Institute's right to levy liquidated damages for the delay in supply.

Liquidated damage will also be levied for the quantity not supplied as is done for the delayed supplies. It should be supplier's responsibility to arrange for inspection, despatch etc. in time to keep up the delivery schedule.

If the ordered materials are not delivered, the purchaser shall recover from the supplier, as liquidated damages, sum of TEN PERCENT (10%) of the contract price of the equipments / materials in addition to the cost of undelivered equipments or materials, besides forfeiture of Security Deposit.

The suppliers are liable to pay the amount of loss sustained by the Institute in the event of non-execution of orders, if any placed on them, either in full or part to the satisfaction of the Institute under the terms and conditions of the contract and in the event of placing orders for such quantities on some others at a higher price.

It may be noted that the Institute will not produce any definite proven commercial loss incurred solely on account of the delayed delivery.

In the event of cancellation of this order or non completion of supply by the suppliers, then the short supplied items may be ordered afresh. The excess price if any between the original and new contract will be recovered from the original supplier from the amount due to the original supplier either from this contract or from any other contract.

6.10 Force Majeure:

In no event shall either Party have any liability for failure to comply with this Agreement, if such failure results directly from the occurrence of any contingency beyond the reasonable control of the Party, including, without limitation, strike or other labor disturbance, riot, major power failure, war, natural calamities including but not

limited to floods, earthquakes, fire, volcanic eruptions, epidemics, National Emergency, interference by any government or governmental agency, embargo, seizure, or enactment or abolition of any law, statute, ordinance, rule, or regulation (each a " Force Majeure Event"). In the event that either Party is unable to perform any of its obligations under this Agreement because of a Force Majeure Event, the Party who has been so affected shall as soon as may be, after coming to know of the Force Majeure Event, inform the other Party and shall take reasonable steps to resume performance as soon as may be after the cessation of the Force Majeure Event. If the period of nonperformance due to a Force Majeure Event exceeds thirty (30) days, the Party whose ability to perform has been so affected may, by giving written notice, terminate this Agreement.

Settlement of Dispute:

All disputes pertaining to the contract is limited to the jurisdiction of Vice- Chancellor, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore, District Court of Coimbatore and in exceptional cases to the Hon'ble High Court of Chennai. Without prejudice to above, the parties reserve the right to enter into an Arbitration process in accordance with the relevant clause of Arbitration and Conciliation Act,1996.
