The Vice Chancellor welcomed the suggestions from the Academic Council members regarding the implementation of the above during admission. The Vice Chancellor further mentioned about the Committee framed in the University to study and implement B.Voc. Programme under NVEQF.

Dr. U. Jerinabi, Dean, Faculty of Business Administration suggested for allotting certain percentage for Vocational Course students in Undergraduate admission.

Mr. R. Ramachandran, President, CODISSIA expressed that all the Industries are looking for Skill Trained candidates and the students from Vocational group would have more skill training and hence the Vocational group students may be considered for admission to Higher Education.

The Academic Council members unanimously accepted the admission of the vocational group students at the Undergraduate level in principle.

44. The Board of Studies in B.Voc. Programme – Medical Equipment Technology and Food Processing and Engineering held on 9.6.2014:

The Vice Chancellor informed the Academic Council members that the UGC has given approval for starting two B.Voc. degree programmes to the University from the academic session 2014-2015, which provides ambit for multiple entries and exits for the women students who discontinue their course due to societal compulsions.

Mr. R. Ramachandran appreciated the introduction of the programmes and suggested to create awareness among the industries, so that the students would be benefited by means of stipend during their skill training in industries.

The Vice Chancellor also informed the Academic Council members that the University has asked AICTE to increase the students intake to 60 for Food Processing and Preservation Technology, because of the demand for the subject.

Dr. (Mrs.) N. Jaya, Former Dean, Faculty of Home Science seconded the motion.

The motion was passed unanimously.

47. Ratification in the Students' intake capacity for admission for certain programmes from the academic year 2014-2015 & onwards.

The Academic Council suggested the Special Education department to write to RCI for increase in student strength, in case of demand.

48. Procedures to be adopted for recognition of M.Phil. and Ph.D. Guideship

The Academic Council unanimously accepted the procedure.

49. Information about the revised priorities of XII Plan allocation including requirements of Teaching and Non- teaching posts

Based on UGC's letter No. F.9-4/2012 (DU) dated 1st April, 2014 the University had sent the revised priorities of XII Plan allocation including requirements of Teaching and Non-teaching posts.

The UGC conveyed its approval for the above through its letter No. F. 14-1/2012 (DU) dated 25th April, 2014 and informed that the proposal for approval of Teaching and Non-teaching Staff during XII plan period will be placed before the Committee for approval of post and any proposed posts in the priorities of XII Plan allocation should not be filled up prior to approval of UGC.

This was for the information to the Academic Council members.

The Chairperson of the Academic Council stressed that the faculty strength in a department need to be considered while introducing new programmes, because they do have direct effect on academic achievements. The Academic accepted the options in principle.

52. Proposed procedures to be followed for CAS promotions of Faculty

The Academic Council members suggested to change the time line as ‘**within 6 months** from the date from which they are eligible **instead of one year**, however the promotion will be only from the date of eligibility’ and further suggested to host the information in the University website.

Dr. (Mrs.) Minnie Mathew, Director, Women Studies Centre seconded the motion.

The motion was passed unanimously.

53. The Board of Studies meeting in Textiles and Clothing held on 9.6.2014 and 17.6.2014 recommended the following:

The Vice Chancellor explained about the collaborative programmes with Sardar Vallabhbhai Patel International School of Textiles and Management, which will be conducted for both the genders at Sardar Vallabhbhai Patel International School of Textiles and Management; framing of the syllabus, conducting the examinations and issuing of degree certificates will be done by our Institution. However, the programmes are not yet approved by Ministry of Textiles/Ministry of Human Resource Development, it will be offered '***subject to approval of UGC**'.

Dr. (Mrs.) R. Brindha, Professor and Head, Department of Electronics and Communication Engineering enquired whether Science group is necessary **for B.Sc. Fashion Designing and Management**. The Academic Council members suggested to change the eligibility for the above course alone be '**Any group in Higher Secondary**'.

After discussion, the Academic Council approved the collaboration with **Sardar Vallabhbhai Patel International School of Textiles and Management** & the introduction of Undergraduate programmes in principle.

54. Revision in the working timings of the University

The Chairperson of the Academic Council **Dr. (Mrs.) Sheela Ramachandran** informed that the University has introduced Choice Based Credit system for Undergraduate programmes from 2011-2012 & for the Postgraduate programmes from 2012-2013. Under Choice Based Credit System, Skill based, Co-curricular and extra-curricular components have been introduced for Undergraduate and Postgraduate programmes since 2011, which are conducted out of the teaching hours for core curriculum.

Representations have been received from students, parents and other stakeholders to ensure return of students to their residences early enough in order to ensure their safety and security.

As per UGC Guidelines, the Universities/Colleges must have atleast 180 teaching days, with 30 hours of teaching per week. Hence after several rounds of discussion, the University proposed to adopt the Day Order System with teaching days as per the guidelines of the respective Regulatory bodies.

Dr. (Mrs.) G. Santhiyavalli, Associate Professor and HOD, Department of Commerce seconded the motion.

The motion was accepted unanimously.

55. Consideration of the qualification of the existing teachers

The Vice Chancellor asked to give suggestion on the eligibility requirement for the existing staff members. After discussion, the following suggestion was recommended for promotion or Direct Recruitment of faculty working in this University for higher posts.

‘For those faculty members, who have been working in this University for more than 15 years, their educational qualifications may be considered irrespective of their domain subject both for their promotion or Direct Recruitment to higher posts’.

The Vice Chancellor placed her gratitude to all the Academic Council members for their cooperation.

The meeting came to an end, proposing thanks to the Chairperson of the Academic Council.
