Plan of Action – Mentor Institute 2020-2021

The Paramarsh Scheme has been implemented and co-coordinated by Internal Quality Assurance Cell (IQAC) of Avinashilingam Institute for Home Science and Higher Education for Women. Initially, five NAAC Aspirant Higher Education Institutions (HEIs) have been identified by Avinashilingam Institute for Home Science and Higher Education for Women and Memorandum of Understanding (MoU) had been exchanged between the mentor and five mentee institutions for the purpose of Paramarsh Scheme. The institute has plans to include few more NAAC aspiring HEIs also within the duration of the scheme.

The mentee institutions identified are

The mentor institute after a thorough analysis of the functioning of mentee institutions, identified various sectors which require improvement to ensure quality sustenance. Attempts have been made by the mentor to take cognizance of the mechanism of quality assurance in the indentified mentee institutions. Detailed plans of work / action for each of the identified institutions have been chalked out. To steer the participating mentee institutions in a well-defined path of growth and quality, the mentor institute has prepared a manual for the purpose of Paramarsh Scheme.
