With reference to the PM CARE for Children Scheme,

- AICTE reserves two seats per course(Annexure - 03)
- Two Supernumerary seats shall be accorded in Institutions(Annexure - 04).

Criteria: Those children who are issued 'PM CARES Certificate' shall be eligible for admission. So far nobody with certificate approached us for admission.

Hence, it is recommended that,

- Two seats may be allotted for Engineering courses(AICTE).
- Two seats may be allotted for other courses in general.
