1. Sealed tender will be received for the above work by the Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore - 641 043 upto 3.00 pm on 1.8.2024

- 2. The tenders should be in the prescribed form obtainable from the **Registrar**, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore- 641 043.
- 3. Tenders one for the technical bid and another for commercial bid must be submitted in two separate sealed covers and should be addressed to the Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore 43.
- 4. Each renderer must be enclosed Demand Draft in from any Nationalized bank in the favour of **The Registrar**, **Avinashilingam Institute for Home Science and Higher Education for Women**, **Coimbatore 43**. as an Earnest Money Deposit in the commercial bid
- 5. The tender received without Earnest Money deposit will not be considered.
- 6. The EMD of unsuccessful tenders shall be returned.
- 7. When tender is accepted the intimation will be given to the tenderer and within a week from the date of receipt of such intimation, he must pay 1% as further security deposit and enter into an agreement signed and written on stamped paper for Rs. 100/-, purchased @ his cost in the prescribed form for the due fulfillment of the contract.

- 8. 5 % of the value of work done will be deducted in each bill of payment as Withheld amount. The withheld amount so deducted will be refunded after defects liability period. The defects liability period shall be six months from the date of completion of works.
- 9. If the contractor fail to rectify the defects during the above period of six months, after getting due notice from the registrar such defects will be rectified by the another contractor and the amount will be adjusted from the security deposit.
- 10. The Registrar reserves the right to reject any or all the tenders without assigning any reason thereof.
- 11. The work should be completed within the stipulated time.
- 12. With held amount @5%, GST@2% and TDS@2% will be deducted as per the Government rules in each and every bill payable to the contractor.
- 13. Before handing over the work on completion, the contractor should clean up the entire site at his own cost.
- 14. The tenderers should carefully go through the tender schedule and quote their rates for all items.
- 15. The rates should be filled in figures and words neatly taking into account the metric units specified in the tender. Scribblings, over-writings and erasing should be avoided as far as possible. Each and every Erasing, over writing if any should be initialed.
- 16. The amount of each items of work should be worked out with proper care.
- 17. The tender should be submitted along with a covering letter giving full details of the following
 - I) Details of the earnest money deposit remitted.

- 18. The tenders submitted without filling up the tender forms are liable to be rejected.
- 19. The work shall be carried out in the best workmanship manner, and best materials available in the market.
- 20. The entire work covered by the contract shall be maintained at the Contractors risk until the contract is fulfilled and the works are taken over by the Registrar, Avinashilingam Institute for Home Science and Higher Education for Women, Coimbatore 43.
